### 4. Staff Reports:

- (a) Finance Manager, Becky Phillips reported that Driftwood Point financials show operating cash of \$154 thousand and has restricted funds of \$228 thousand. The expenses were over budget due to an increase in internet and phone costs. She also stated that \$4,000 was received for Laundry Income. The vendor that had been collecting it had the account set-up for a yearly payment. That has since been changed so the vendor will now send the collections monthly. Driftwood Tax Returns are still waiting to be finalized by the CPA. It has been delayed due to last minute tax law changes regarding depreciation.
- (b) Katie Bonus, Director of Operations, reported on the JPCHA properties as outlined on her report. Overall occupancy is 98% for the four properties. All properties, except Timberland, have waiting lists. Late rent payments are exceptionally low, and none have related that it is due to COVID. They have all been sent repayment plans. It was suggested by Kathy Spoor to investigate if any of the funds available for landlords would be available to us. Katie also

mentioned that the current maintenance person for Driftwood is out with a shoulder injury. HOSWWA maintenance staff have been taking care of maintenance issues as needed. A new property manager has been hired and is doing well. Kathy Spoor asked if the waiting lists for the current properties be able to transfer to Willapa Center when it opens. Katie replied that they would not.

### 5. Consent Agenda:

(a) Commissioner Davis motioned to pass the Consent Agenda. Commissioner Overby seconded the motion. Passed unanimously.

We are still waiting for a response from Ecology regarding our contesting the Notice of Further Action required by the Dept of Ecology for Driftwood Pointe. Today is the groundbreaking ceremony for Willapa Center. The closing for this property needs to close by July 15.

We have received sufficient funds to move forward with the Pacific Place project. JPCHA will have two projects going one at the same time. Secretary Westerman also mentioned that 42 Emergency Housing Vouchers have been received to be used for homeless individuals and/or families. She will be moving forward to get MOUs in place. These vouchers will be available for all four counties that the agency services. Willapa Landing project has been put on hold at this time. It will be revisited next year for viability. Kathy Spoor asked if there would be a risk of losing this property. Ms. Westerman stated that would not be an issue due to 10-year HAP. Ms. Spoor stated that it seemed like "now" would be a good time for obtaining funding with all of the various funding opportunities currently in place.
