There will now be a vapor mitigation system put in where the gas station was, this has added 20 days to the development. Willapa Landing Update:

Asset Manager, Katie Bonus, updated the Board on Willapa Landing. There are three mortgages on the building. There have been discussions with HUD to possibly forgive their loans on the building with certain requirements. Commissioner's discussed in length the status of the property and what would need to be fixed. Commissioner, Jan Davis stated her concerns about the property if HUD were not willing to forgive the loan. Asset Manager, Katie Bonus, will find out more information from HUD and see if JCPHA can have a guarantee that they will forgive debt before purchase.

Approval to Increase Application Feeds for JPCHA properties:

Asset Manager, Katie Bonus requested to increase the application fee from \$34.00 to \$36.00.

Commissioner, Jan Davis motioned to raise the application fee. Commissioner, Julie Overby seconded the motion. Passed unanimously.
