**Purpose.** The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, including changes to these policies, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families

**Applicability.** The Form HUD-50075-HCV is to be completed annually by **HCV-Only PHAs**. PHAs that meet the definition of a Standard PHA, Troubled PHA, High Performer PHA, Small PHA, or Qualified PHA do not need to submit this form. Where applicable, separate Annual PHA Plan forms are available for each of these types of PHAs.

**Definitions.**

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers, and was designated as a high performer on both the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments if administering both programs, or PHAS if only administering public housing.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceed 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceed 550, and that was designated as a standard performer in the most recent PHAS and SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined and is not PHAS or SEMAP troubled.

<b>B.2</b>	<p><b>New Activities. – Project Based Vouchers</b></p> <ul style="list-style-type: none"> <li>• HOSWWA anticipates project basing 20 HCV in Sunrise Village, a 40-unit new construction LIHTC project in Longview WA. We are also seeking approval from the VA to Project Base 2 VASH vouchers. Project is scheduled to begin construction late 2023. We are currently working on the subsidy layering review.</li> <li>• HOSWWA may seek to project base vouchers in Pacific County in alignment with development activities.</li> </ul> <p>Project basing units is a goal of the Housing Authority, and is declared under new goals of the 5-year Plan, B.2.1.a and B.2.6.a and b to work closely with Coordinated Entry agencies in all our county jurisdictions, and to expand on partnerships for services in this project. B.2.8 Attaching PBV continues to fulfill our goal of expanding affordable housing opportunities in our jurisdictions.</p>

<p><b>B.3</b></p>	<p><b>Progress Report.</b></p> <ol style="list-style-type: none"> <li>1. <b>Goal: Provide greater access to affordable housing by increasing the number of homes available to low and medium income families across jurisdictions.</b> <ol style="list-style-type: none"> <li>a. <b>COMPLETED:</b> Completed construction on Driftwood Point, a 27 unit project located in Long Beach, WA utilizing funding from Low Income Housing Tax Credits and Housing Trust Fund. This project is owned by Joint Pacific County Housing Authority, in partnership with HOSWWA. This project is managed by HOSWWA.</li> <li>b. <b>IN PROGRESS:</b> Willapa Center, located in Raymond, WA in nearly complete. We anticipate leasing in August 2023.</li> <li>c. <b>IN PROGRESS:</b> Sunrise Village a new project located on 38<sup>th</sup> and Pennsylvania Street in Longview, Washington has been fully funded. We are in the design phase and anticipate beginning construction in September 2023. This 40 unit project will have 20 PBV for the 20 homeless units. Land was donated by the Longview Presbyterian Church.</li> <li>d. <b>IN PROGRESS:</b> HOSWWA owns 6 acres of land on Ocean Beach Hwy in Longview. Working on development plans. On two of these acres we hope to develop homeownership units that will be made available to our voucher homeownership program and other low income persons.</li> <li>e. <b>IN PROGRESS:</b> Increase affordable homeownership opportunities through development of new housing, and the Section 8 homeownership program. We have a new lender in UMPQUA Bank who is willing to work with our voucher holders to qualify.</li> <li>f. <b>IN PROGRESS:</b> Continue development and preservation of affordable housing. This will be done through development of new housing and acquisition/rehab of existing housing throughout our jurisdiction as opportunities arise. In 2022/23 we acquired Pacific Place for Joint Pacific County Housing Authority. This 24 unit senior housing USDA property has been rehabilitated and preserved. We are in process of acquiring and rehabilitating Alder House in Pacific County. Post rehabilitation this project will have 35 units for seniors. We may explore project based vouchers in this location. The property will be managed by HOSWWA.</li> </ol> </li> <li>2. <b>Goal: HOSWWA continues to work diligently towards 100% utilization of Housing Choice Vouchers as long as sufficient funding is appropriated by Congress.</b></li> <li>3. <b>Goal: Expand the supply of assisted housing by applying for additional rental vouchers and tenant based rental assistance when opportunities arise.</b> <ol style="list-style-type: none"> <li>a. HOSWWA continues to apply for new vouchers as they become available and has been successful in obtaining more MS5 and VASH vouchers and received an award of Stability vouchers.</li> <li>b. any contribution or consultation requirement with respect to any applicable AFH, in accordance with 24 CFR 5.150 through 5.180; (vii) maintains records reflecting these analyses, actions, and the results of these actions; and (viii) takes steps acceptable to HUD to remedy known fair housing or civil rights violations, impediments to fair housing choice within those programs; addresses those impediments in a reasonable fashion in view of the resources available; works with the local jurisdiction to implement any of the jurisdiction's initiatives to affirmatively further fair housing; and assures that the annual plan is consistent with any applicable Consolidated Plan for its jurisdiction. **C.4 Challenged Elements.** If any element of the Annual PHA Plan or 5-Year PHA Plan is challenged, a PHA must include such information as an attachment to the Annual PHA Plan or 5-Year PHA Plan with a description of any challenges to Plan elements, the source of the challenge, and the PHA's response to the public.

**D. Affirmatively Furthering Fair Housing (AFFH).**

**D.1 Affirmatively Furthering Fair Housing.** The PHA will use the answer blocks in item D.1 to provide a statement of its strategies and actions to implement each fair housing goal outlined in its accepted Assessment of Fair Housing (AFH) consistent with 24 CFR § 5.154(d)(5) that states, in relevant part: "To implement goals and priorities in an AFH, strategies and actions shall be included in program participants' ... PHA Plans (including any plans incorporated therein) ... Strategies and actions must affirmatively further fair housing ...." Use the chart provided to specify each fair housing goal from the PHA's AFH for which the PHA is the responsible program participant – whether the AFH was prepared solely by the PHA, jointly with one or more other PHAs, or in collaboration with a state or local jurisdiction – and specify the fair housing strategies and actions to be implemented by the PHA during the period covered by this PHA Plan. If there are more than three fair housing goals, add answer blocks as necessary.

Until such time as the PHA is required to submit an AFH, the PHA will not have to complete section D., nevertheless, the PHA will address its obligation to affirmatively further fair housing in part by fulfilling the requirements at 24 CFR 903.7(o)(3) enacted prior to August 17, 2015, which means that it examines its own programs or proposed programs; identifies any impediments to fair housing choice within those programs; addresses those impediments in a reasonable fashion in view of the resources available; works with local jurisdictions to implement any of the jurisdiction's initiatives to affirmatively further fair housing that require the PHA's involvement; and maintain records reflecting these analyses and actions. Furthermore, under Section 5A(d)(15) of the U.S. Housing Act of 1937, as amended, a PHA must submit a civil rights certification with its Annual PHA Plan, which is described at 24 CFR 903.7(o)(1) except for qualified PHAs who submit the Form HUD-50077-CR as a standalone document.
