Purpose. The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, including changes to these policies, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families

Applicability. The Form HUD-50075-HCV is to be completed annually by HCV-Only PHAs. PHAs that meet the definition of a Standard PHA, Troubled PHA, High Performer PHA, Small PHA, or Qualified PHA do not need to submit this form. Where applicable, separate Annual PHA Plan forms are available for each of these types of PHAs.

## Definitions.

(1) High-Performer PHA - A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers, and was designated as a high performer on both the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments if administering both programs, or PHAS if only administering public housing.
(2) Small PHA - A PHA that is not designated as PHAS or SEMAP troubled, that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceed 550 .
(3) Housing Choice Voucher (HCV) Only PHA - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
(4) Standard PHA - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceed 550 , and that was designated as a standard performer in the most recent PHAS and SEMAP assessments.
(5) Troubled PHA - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
(6) Qualified PHA - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined and is not PHAS or SEMAP troubled.

B. 2 New Activities. - Project Based Vouchers

- HOSWWA anticipates project basing 20 HCV in Sunrise Village, a 40-unit new construction LIHTC project in Longview WA. We are also seeking approval from the VA to Project Base 2 VASH vouchers. Project is scheduled to begin construction late 2023. We are currently working on the subsidy layering review.
- HOSWWA may seek to project base vouchers in Pacific County in alignment with development activities.

Project basing units is a goal of the Housing Authority, and is declared under new goals of the 5-year Plan, B.2.1.a and B.2.6.a and b to work closely with Coordinated Entry agencies in all our county jurisdictions, and to expand on partnerships for services in this project. B.2.8Attaching PBV continues to fulfill our goal of expanding affordable housing opportunities in our jurisdictions.

| B. 3 | Progress Report. <br> 1. Goal: Provide greater access to affordable housing by increasing the number of homes available to low and medium income families across jurisdictions. <br> a. COMPLETED: Completed construction on Driftwood Point, a 27 unit project located in Long Beach, WA utilizing funding from Low Income Housing Tax Credits and Housing Trust Fund. This project is owned by Joint Pacific County Housing Authority, in partnership with HOSWWA. This project is managed by HOSWWA. <br> b. IN PROGRESS: Willapa Center, located in Raymond, WA in nearly complete. We anticipate leasing in August 2023. <br> c. IN PROGRESS: Sunrise Village a new project located on $\mathbf{3 8}^{\text {th }}$ and Pennsylvania Street in Longview, Washington has been fully funded. We are in the design phase and anticipate beginning construction in September 2023. This 40 unit project will have 20 PBV for the 20 homeless units. Land was donated by the Longview Presbyterian Church. <br> d. IN PROGRESS: HOSWWA owns 6 acres of land on Ocean Beach Hwy in Longview. Working on development plans. On two of these acres we hope to develop homeownership units that will be made available to our voucher homeownership program and other low income persons. <br> e. IN PROGRESS: Increase affordable homeownership opportunities through development of new housing, and the Section 8 homeownership program. We have a new lender in UMPQUA Bank who is willing to work with our voucher holders to qualify. <br> f. IN PROGRESS: Continue development and preservation of affordable housing. This will be done through development of new housing and acquisition/rehab of existing housing throughout our jurisdiction as opportunities arise. In 2022/23 we acquired Pacific Place for Joint Pacific County Housing Authority. This $\mathbf{2 4}$ unit senior housing USDA property has been rehabilitated and preserved. We are in process of acquiring and rehabilitating Alder House in Pacific County. Post rehabilitation this project will have 35 units for seniors. We may explore project based vouchers in this location. The property will be managed by HOSWWA. <br> 2. Goal: HOSWWA continues to work diligently towards $100 \%$ utilization of Housing Choice Vouchers as long as sufficient funding is appropriated by Congress. <br> 3. Goal: Expand the supply of assisted housing by applying for additional rental vouchers and tenant based rental assistance when opportunities arise. <br> a. HOSWWA continues to apply for new vouchers as they become available and has been successful in obtaining more MS5 and VASH vouchers and received an award of Stability vouchers. <br> b. We are applying for both FUP and FYI Vouchers. <br> 4. Goal: Promote self-sufficiency and asset development of assisted households. HOSWWA will pursue funding opportunities to expand the Rent Well Program to improve tenant education and rental housing choice options. Still pursuing grants for expanding rent well. <br> a. We have submitted a grant request to the City of Longview for expansion of the Rent Well program. <br> 5. Goal: Ensure equal opportunity and affirmatively further fair housing by providing continuous training opportunities for staff and undertaking affirmative measures to ensure accessible housing to all. <br> a. Seeking a new position that can help the agency to comply with the new fair housing regulations and develop a fair housing plan for our region. <br> 6. IN PROGRESS: Actively leverage partnerships and community engagement to increase effectiveness and expand opportunities. <br> a. Improve outreach efforts to increase awareness about available programs by enhancing partnerships with the Coordinated Entry agencies in each County, local Rental Property Owner's Associations, Lower Columbia CAP, DSHS and Willapa Behavioral Health by continuing informational sharing events and trainings. <br> b. Work with local service providers to identify potential partnership opportunities to expand the supply of housing and supportive services. Many new partnerships have been developed with agencies across our jurisdiction. <br> c. Provide development assistance to smaller partner agencies to increase affordable housing options in rural areas outside the City of Longview to include Wahkiakum, Lewis and Pacific Counties. <br> 7. IN PROGRESS: Create and implement tools to thrive <br> a. Continue to improve program integrity and quality of service by working to identify administrative efficiencies and streamlining procedures. <br> b. HOSWWA has implemented new software (Yardi) which includes an applicant, tenant, landlord portal and increases access to services. <br> 8. IN PROGRESS: Due to modifications in supportive services grant funds from Veterans Affairs (VA) distributed to the Veteran Integration Program (VIP) department of HOSWWA, a reassessment and reorganization has been fully implemented to better serve homeless veterans in the HA's jurisdiction. HOSWWA is seeking new funding sources to expand into a full supportive housing program available to HOSWWA tenants. <br> a. HOSWWA received a technical assistance grant to investigate implementation of Foundational Community Supports or FCS. This program available through the state of Washington provides funding for case management services. We are hoping to offer voluntary case management services to any of our voucher clients or housing clients that are in need. |
