1. CALL TO ORDER

- a) Chair Knapp called the meeting to order at 5:03 p.m.

a) Commissioner Rudberg brought up concerns regarding having a disaster plan. For example, what is the plan if the power goes out while someone wheelchair-bound is on the elevator? Commissioner Rudberg is asking if the board should have a committee to look into such issues. Chair Knapp thinks this is a good thought but that it should be done by staff. Commissioner Rudberg clarified that this would be a request from the board to staff to form this committee. Chair Knapp suggested that the Board wait and reach out to Katie as she suspects a lot of the necessary plans are already in place.

Secretary Westerman responded to say that while the elevators do have a disaster plan in place, HOSWWA does need to develop an all-inclusive disaster plan. The work to develop a disaster plan was started a few years ago and was tabled. Secretary Westerman feels we will need a consultant to help develop the plan and a consultant would need board approval as it was not budgeted for. Chair Knapp proposed that HOSWWA could look at what plans are in place and can work a consultant into the budget and Strategic Plan in the upcoming budget season.

Commissioner Rudberg added that the County has some videos that are related to disaster plans and may have some advice on how to go forward.
